Calhoun County REC Offers Basin Power Electric

Dependents of members of Calhoun County REC are eligible to **apply for a \$1,000 scholarship** to be provided by Basin Electric Power Cooperative and Corn Belt Power Cooperative, power suppliers of Calhoun County REC. 11C34PA

The scholarship program is designed to encourage and recognize the achievements of a student living on electric cooperative lines. The scholarship must be used for educational costs and the student must enter college in the fall of the school year for which the scholarship is given. The applicant must be a student who is enrolled or planning

to enroll in a full-time graduate or undergraduate course of study at an accredited, two year or four-year college, university or vocational/technical school. This scholarship is awarded without regard to other awards, loans or financial assistance the applicant may have obtained. Award of the scholarship is based on the following criteria: SAT/ACT scores, grade-point average, work experience, participation in school and community activities, a statement by the student explaining his/her educational and career goals and a written recommendation by a third party. Applicants for the

scholarship will first be screened by their cooperative. Each member cooperative may forward one finalist to Corn Belt Power Cooperative to be considered for the scholarship. **Deadline is on or before February 14th at the Calhoun County REC office. Member Satisfaction On the Rise!

Members of the Calhoun County REC have given the cooperative its best score since the start of the survey in 2001.

In the fall of 2017, Calhoun County REC improved by scoring a 91 on a 100-point scale. Responses to the American Customer Satisfaction Index (ACSI) questions continue to be consistently high - the 2017 ACSI score of 91 is the highest score ever received. The ACSI survey is a combination of both telephone and online responses from 250 randomly selected member-owners. This score is higher than the national cooperative average (77) and MidAmerican Energy (72) as well as the averages for investor-owned utilities (72) and municipal utilities (68).

The ACSI survey uses the same questions year after year and throughout the industry, making the ACSI survey the only statistically valid comparison that provides a uniform, cross-industry measure of customer satisfaction.

The four key areas measured in the ACSI survey, compared to the previous survey, are as follows:

- **91% overall satisfaction (81% in 2015)**
- **85% say Calhoun County REC has greatly exceeded their expectations (72% in 2015)**
- **89% say Calhoun County REC is very close to being an ideal utility company (74% in 2015)**
- **88% would choose Calhoun County REC again as their electric utility company (66% in 2015)**

Your Cooperative's employee team and board of directors would like to thank our member-owners for helping us achieve a score of 91 on our latest survey. "The ACSI score is a good benchmark for our co-ops to determine if we are meeting the expectations of our members-owners and that we continue to serve in their best interest. . Our Board of Directors and employees are dedicated to put our member-owners first. I believe the success of that effort is reflected in our ACSI score", explains CEO Roxanne Carisch. Our commitment to keeping rates affordable and making system improvements that increase reliability no doubt contribute to the high score.

Look out for scams

Unfortunately, in today's world, scams are inevitable. Scammers can threaten you with everything from legal action involving the IRS to turning off power to your home.

Utility scams often involve an individual or group posing as an employee of your electric cooperative. The scammer may use threatening language in order to frighten you into offering your credit card or bank account information. Don't fall victim to these types of scams.

Understand the threats posed and your best course of action:

- If someone calls your home or cell phone, demanding you pay your electric bill immediately, gather as much information as you can from that individual, hang-up the phone and contact the local authorities. Scammers often use threats and urgency to pressure you into giving them your bank account number or loading a pre-paid credit or debit card (such as a Green Dot card). Calhoun County REC will **never** ask you to offer up personal finance information over the phone. If you have any doubts about your utility bill, contact our billing supervisor at 712-297-7112.
- If someone comes to your home claiming to be an employee of Calhoun County REC that needs to collect money or inspect parts of your property, call

us to verify they are, in fact, an employee. If they are not, call local authorities for assistance and do not let the individual into your home. 16C04LA

There are other types of scams consumers should watch out for:

- Government agencies like the IRS will never call to inform you that you have unpaid taxes or other liens against you. You will always receive this type of information in the mail. If someone calls claiming to be the IRS, hang-up immediately.
- If you receive an email from an unknown sender; an email riddled with spelling errors and typos; or an email threatening action unless a sum of money is paid, do not click any links provided within the email, and do not respond to the email. Simply delete the email, or send it to your spam folder.
- If someone calls your home claiming to have discovered a virus on your computer, hang-up. This caller's intent is to access personal information you may be keeping on your computer.

Calhoun County REC wants to make sure you avoid any and all types of scams that could put you or your financial information in jeopardy. RECIPE OF THE MONTH

POTATO SKIN BITES

INGREDIENTS:

- | | |
|-----------------------------------|-------------------------------|
| 3 russet potatoes, scrubbed clean | 6 slices bacon, |
| 2 tbsp. olive oil | cooked and |
| kosher salt | crumbled |
| Freshly ground black pepper | 1 1/2 c. shredded Cheddar |
| Pinch cayenne pepper | 3 green onions, thinly sliced |
| 1 tsp. garlic powder | Sour cream, for serving |



DIRECTIONS:

1. Preheat oven to 400°. Slice potatoes into 1/2" coins.
2. In a large bowl, toss the potato rounds in olive oil. Season with salt, pepper, cayenne and garlic powder, and toss until evenly coated. Place in a single layer on a large baking sheet. Bake for 30-40 minutes, until lightly browned and tender, flipping halfway through.
3. Top each potato round with cheese and bacon. Broil until melty, about 2 minutes.
4. Dollop sour cream onto each potato and garnish with green onions.

Reducing Power Outages Through Tree Trimming

In a review of power outages it was determined trees were the third most common cause of outages in terms of the number of consumers affected and the number of hours the outages lasted.

If you believe a tree is too close to the line (within 10 feet), please notify us at 712-297-7112. A properly trained employee will trim trees that are near Cooperative lines leading up to your meter. Electrical lines you own, that lead from the meter to your house or farm, are your responsibility to maintain.

If an employee notices a tree in or near an electric line, the tree will be trimmed or cut to remove the hazard. We realize this may not always agree with your home landscaping plans, however safety and uninterrupted power must be our first priorities.

Energy Cost Adjustment

When the cost of power decreases, we pass the savings on to our member-owners. However, when the cost of power increases, we also must adjust the costs for our member-owners.

The “energy cost adjustment” (ECA) is exactly that – a way to adjust the fluctuating monthly cost of wholesale power over or under the established kWh rate. 27G06CA

When Calhoun County REC receives our power bill from Corn Belt, our power provider, any increases or decreases in power costs from the normal base kWh rate is passed on to the member-owner using the ECA.
