Youth Tour Opportunity!

Calhoun County REC will be offering high school sophomores and juniors an opportunity to be selected for a trip to Washington D.C. June 8-14, 2018. Scholarships Offered Administered by Northwest Iowa Community College

Corn Belt Power is partnering with the Northwest Iowa Community College to offer up to four \$500 scholarships. Applicants must be enrolled in one of the following technical programs at Northwest Iowa Community College: **Electrical Technology, Powerline, Powerline Technology or Substation Technician.** Recipients may be either first or second year students, but are eligible for only one scholarship. Each scholarship will be split equally between the first two semesters of enrollment after receiving the scholarship. Scholarship proceeds may be used for tuition, fees and books. To be considered a candidate for the Corn Belt Cooperative Scholarship, applicants must meet the following criteria:

- 1. Reside in a county served by a member cooperative of Corn Belt Power
- 2. Achieve a high school grade point average of 2.5 on a 4.0 scale
- 3. Accepted as a full time student in one of the identified programs at Northwest Iowa Community college
- 4. File scholarship applications with the Northwest Iowa Community College Foundation by March 1, 2018
- 5. Maintain 2.5 minimum grade point average; eligibility shall be reviewed each semester.

All applicants are required to submit a letter of reference from a high school instructor, guidance counselor, current employer or manager of a member electric cooperative with their applications. This reference should address the applicant's potential for success in the program chosen for enrollment. The primary criteria for the award will be the candidate's potential for success and grade point average. Corn Belt Power is partnering with Iowa Lakes Community College to offer a scholarship opportunity to students who study wind energy and turbine technology. Applicants must be enrolled in the Wind Energy and Turbine Technology program at Iowa Lakes Community College. One \$500 scholarship will be awarded annually to an individual who has met the requirements set forth. Recipients may be either first or second year students, but are eligible for only one scholarship. Each scholarship will be split equally between the first two semesters of enrollment after receiving the scholarship. Scholarship proceeds may be used for tuition, fees and books. To be considered a candidate for the Corn Belt Cooperative Scholarship, applicants must meet the following criteria:

- 1. Achieve a high school grade point average of 2.5 on a 4.0 scale.
- 2. Accepted as a full time student in the identified program at Iowa Lakes Community College
- 3. Must be an Iowa resident
- 4. File scholarship application with Iowa Lakes Community College by April 1, 2018
- 5. Maintain 2.5 minimum grade point average; eligibility shall be reviewed each semester.

RECIPE OF THE MONTH

CREAMY POTATO SOUP

INGREDIENTS:

2 Tbl butter

½ cup chopped onion

1 stalk celery chopped (1/2 cup)

1 ¾ cups chicken broth



3 medium potatoes peeled and cubed

- 1 ½ cups milk
- 1 Tbl chopped parsley


DIRECTIONS:

Heat the butter in a 3-quart saucepan over medium heat. Add the onion and celery and cook until tender. Stir the broth and potatoes in the saucepan and heat to a boil. Reduce the heat to low. Cover and cook for 15 minutes or until the potatoes are tender. Place half of the broth mixture and half of the milk in a blender or food processor. Cover and blend until smooth. Repeat with the remaining broth mixture and remaining milk. Return to the saucepan and heat through. Season to taste. Sprinkle with the parsley before serving. 13C10LA

Line patrol a part of our reliability plan

As the weather gets too cold for line construction, your electric cooperative linemen switch gears and begin line patrol. Line patrol involves line crews driving lines in selected townships and taking note of how lines, poles and equipment are holding up. Trouble areas, such as trees growing too close to poles and wires, are marked down as potential candidates for repair when construction season comes around again. So if you see electric cooperative vehicles come into your yard, they are likely checking equipment up to the meter and transformer. Likewise, if you see cooperative trucks driving slowly on the road, take care when you pass. Your linemen are out ensuring that you have the most reliable service possible by making sure the lines, transformers and equipment on your distribution system are in working order. Line patrol is another duty performed by your electric co-op to show how they work to serve you winter, spring,

Patronage checks were mailed on December 14th to member-owners who purchased electricity from the Cooperative in the year 2000. Allocation and retirement (return) of patronage to member-owners is an important difference between electric cooperatives and investor-owned utilities. Calhoun County REC does not have stockholders and does not pay dividends. 23S16LA

At the end of each year, after all of the Cooperative's bills have been paid and all expenses considered, the amount of money that is left over is called a margin. Margins provide equity for the Cooperative and are allocated to the member-owners in proportion to their purchases of electricity

during the year. Calhoun County REC returns excess margins on a schedule determined by the Board of Directors. This is done in the form of patronage.

Each year the decision to return patronage is made based on the financial stability of the Cooperative. The Board selects if, how and when patronage is returned to the membership. In 2017 the amount returned was in relation to the individual member-owner's amount of electricity used with the Cooperative in the year 2000.

Over 150 directors, managers and staff members from Iowa's electric cooperatives discussed priorities with state legislators and policy makers on January 9th during the annual Welcome Back Legislative Reception at the State Historical Building in downtown Des Moines. Other guests of honor included: Governor Kim Reynolds, Lieutenant Governor Adam Gregg, Secretary of Agriculture Bill Northey, Auditor of State Mary Mosiman, Attorney General Tom Miller, Iowa Utilities Board Member Nick Wagner, and Iowa Department of Economic

Development Director Debi Durham. The Iowa Association of Electric Cooperatives, in conjunction with the Iowa Biotechnology Association, the Iowa Institute for Cooperatives, the Iowa Communications Alliance and the Petroleum Marketers and Convenience Stores of Iowa, hosted the annual reception.

In the coming months, the Iowa General Assembly will be addressing a multitude of issues, including items central to Iowa's rural economy. Beginning with the Welcome Back Legislative Reception, the directors, managers, and staff will again be important advocates for a balanced approach in addressing energy issues allowing Iowa's member-owned electric cooperatives to continue providing safe, reliable, affordable,

and environmentally responsible power to more than 650,000 Iowans.

Electric cooperative representatives from all parts of the state will come to the state capitol in the next couple of months to visit with their legislators once again. The annual REC Day on the Hill will be held on March 14, 2018, at the capitol.
