

Leadership REPOR

For 88 years, Calhoun County Electric Cooperative Association has been Creating Powerful Connections. We've been committed to the mission of providing our member-owners safe, reliable, and responsible electric service at a fair price from the very beginning. Your cooperative works to power homes, farms, businesses, and schools and we've continued to find ways to improve safety, reliability, and the value of electricity while investing in our communities to improve the lives of our members. 2023 was no exception as we continued to successfully accomplish that mission.

Last year, we distributed over 43.5 million kilowatt-hours of electricity to our 1,168 members and their 1,685 services over 759 miles of power lines. At just 2.2 meters per mile of line, our team of 11 employees cover a lot of ground. We have six of the best linemen around in our operations department, led by Line Superintendent, Bret McAlister and his 29 years of experience. We also have an outstanding group of dedicated office employees, working locally to serve our members needs around the clock.

System Investment & Reliability –

In 2023, we invested over a million dollars in needed infrastructure improvements such as line reconstruction, pole replacements, tree trimming, and equipment maintenance, which helps ensure reliability. Our overall system reliability as a percentage of time was over 99.99% which is exceptional for our industry. On average, members experienced an average of just 1.1 outages in 2023, with an interruption duration per member of 43 minutes. In comparison, the Iowa REC average was 87 minutes and rural investor-owned customers experienced an average of 102 minutes of interruption in 2023. We know you count on us to power your homes, farms, and businesses, and we do our best to provide reliable service to our member-owners.

We saw everything from poles and wire to transformers and trucks maintain their elevated costs. Lead times for basic materials have gotten a bit better, so we're feeling less

stress when placing orders. We continue to see, within the industry, a rapid transition to renewable energy sources such as wind and solar power, along with increased demand for electricity which is setting the electric grid up to be less reliable. As the industry shifts away from traditional, always available resources such as coal, power supply is becoming increasingly dependent of the weather and frequently stretched. At the same time, we've seen a nationwide push for the increased electrification of our homes, businesses. and the transportation sector. Regulatory and market pressures have influenced the type of generation being added to a complex system we call "the grid". Simply put, wind and solar have replaced firm, always available, generation with an intermittent alternative that can be unpredictable. Fortunately, the generation you are served with is comprised of a strategic mix of resources such as coal, natural gas, and renewables, all working together to bring you reliable service.

Culture of Safety -

Safety remains the top priority at CCECA. Last year, our employees worked 23,947 hours safely, bringing our total number of accident-free hours to over 665,000 - an accomplishment that spans all the way back to 1997. We demonstrate a commitment our employees' safety by training monthly on general and industry specific hazards. CCECA is also an active participant in Commitment to Zero Contacts Phase II, a nationwide safety program focused on ensuring our line workers return home safely each night. From time to time, our employees work in less-than ideal conditions and their continued focus on safety must be recognized, and we applaud the effort they've put forth to work safely!

The Value of Electricity -

One of the most important responsibilities of the cooperative's board and leadership is to maintain financial stability while providing electric service to you, the member, at the lowest cost possible. The average residential member spends about \$5.25 per day for electricity. When you compare that to just about any other daily necessity, the electricity you receive to power almost every aspect of your farm, home, or business remains an incredible value and we work to keep it that way.

Value of Cooperative Membership

In 2023, the CCECA Board of Directors voted to return over \$188,000 to its members. A combination of Capital Credits from 2006 and 2022 were sent back in August. Having a locally elected board, able to make these kinds of decisions, is a strong example of the cooperative difference and a benefit of being a member of a not-for-profit electric cooperative.

Commitment to Our Communities -

We continue to enhance our communities by investing in projects and people that make a difference, improving all our lives. Our revolving loan fund (RLF) was a source of financing for a hardware store in Manson in 2023. The fund, established using a grant from USDA, has also been used for local medical and emergency response facilities, restaurants, retail, and recreational businesses. We also utilized USDA's Rural Economic Development Loan Program in 2023 to provide a \$1.5 million pass-through loan to Dobson Pipe Organ Builders of Lake City to help rebuild after a devastating fire destroyed their facility. We also continue to invest back into our area students through scholarships, the Washington D.C. Youth Tour program, and through donations to our local County Fair and youth organizations.

We hope to see you at our Member Appreciation Event and Annual Meeting in September and look forward to working on behalf of you, our member-owners into the future. At Calhoun County Electric Cooperative Association, we're **Creating Powerful Connections.**

Corn Belt Power Cooperative REPORT

This year's theme, "Blueprinting for Our Future," encapsulates the essence of progress and growth in a world driven by innovation and constant change. As we navigate the everevolving landscape of our industry, it is crucial to proactively prepare for the future while upholding the high service standards our member-cooperatives rely on.

Financially, Corn Belt Power Cooperative remains robust, exemplified by the \$8,777,858 returned to its membership through annual quick rolls and patronage payments in 2023. Achieving an "A" rating from both S&P Global Ratings and Kroll Bond Rating Agency further underscores the cooperative's financial strength.

Corn Belt Power continues collaborate with policymakers and regulators on state and federal levels advocating for an inclusive "all-ofthe-above" generation strategy in response to challenges outlined in the 2023 Summer and Winter Reliability Assessments from the North American Electric Reliability Corporation (NERC). This strategic initiative aims to incorporate all energy sources, ensuring reliability and affordability in the face of operational challenges observed in the Southwest Power Pool system.


Corn Belt Power began to see benefits from its new battery storage facility. Throughout 2023, the system saved \$277,260 using the battery during times of peak electric demand. When added to the entire load management system, Corn Belt Power saved members more than \$2.3 million in demand charges. Corn Belt Power's vigilance extended to its Wisdom Station power plant and shared coal units on the Missouri River. These units continue to provide vital peak and baseload generation when needed, despite reduced utilization compared to five years ago.

Membership in the SPP regional tariff continue to yield positive economic results, leading to the upgrade or rebuilding of 69.72 miles of transmission line. Simultaneously, electrical maintenance and meter significant undertook crews infrastructure improvements, replacing aging components, upgrading relays and wiring, and installing new radios and fiber connections across the system.

The cooperative also addressed the need for modernized storage facilities, opening a new vehicle storage facility and warehouse in 2023 to accommodate the growth and increased size of equipment over the past 70 years.

In the realm of cybersecurity, Corn Belt Power made notable strides by introducing a new phone system, security update system, disaster recovery procedure and security protocols. A comprehensive cybersecurity penetration test at the end of 2023 ensures a robust defense against potential threats, reflecting the cooperative's commitment to technological resilience.

In 2023, Corn Belt Power embraced the theme "Blueprinting for Our Future" within the dynamic energy industry landscape. With a dedicated focus on progress and growth, the cooperative proactively prepared for the future while maintaining high service standards. From fortifying infrastructure transmission technology safegaurding assets, Corn Belt Power persistently strides towards the future, committed to delivering safe, reliable and affordable services.




Report of NOMINATING COMMITTEE

DUTIES of a **DIRECTOR**

A director has the fundamental responsibility to represent prudently the interests of all the members as a group, in directing the business and affairs of the cooperative system, within the law, while ensuring sound fiduciary responsibility cooperative to the system.

Duty of Diligence: Prior to making a business decision, a director has an obligation to inform himself/herself of all material information and education reasonably available to him/her.

Duty of Loyalty: This duty requires directors to refrain from engaging in personal activities which would injure or take advantage of the system. A director is prohibited from using his/her position of trust and confidence to further his/her own private interest. This duty also requires directors to keep information presented and discussed at Board meetings confidential until there has been a general public disclosure.

Duty of Obedience: Under this duty, directors are required to perform their duties in accordance with applicable state and federal statues as well as the system's bylaws and articles of incorporation.



District 2 Director Retiring After 12 Years

Thank you to Ron Hanson for your dedicated service on the Board of Directors for the last 12 years. Ron represents District 2 on the Board and is currently serving as Treasurer.

At Calhoun County Electric Cooperative, Directors are elected by the members in their district and serve a three-year term. The Board is made up of one Director from each of the seven districts. Each member has the opportunity to particiate in the democratic election process.

ANNUAL MEETING OF MEMBERS - September 7, 2023

The 87th Annual Meeting of the Members of Calhoun County Electric Cooperative Association was held at the headquarters in Rockwell City, lowa on the 7th day of September, 2023.

The meeting was called to order by Jim Miller, President of the Cooperative, who presided, and Jason McKenney, acted as Secretary of the meeting and kept the minutes thereof.

The Chairman stated that the members who had registered at the door had been checked, and that a quorum was present for the transaction of business. A motion was duly made, seconded, and carried to accept the registration in lieu of a roll call. A list of members who registered in attendance at the meeting is attached to these minutes and made a part hereof by reference.

The Chairman noted that the Notice of the Annual Meeting of Members was mailed to all members of the Cooperative, and such notice and proof of mailing were ordered to be annexed to the minutes of this meeting.

The Chairman inttroduced the directors and employees.

The Chairman offered to read the minutes of the Annual Meeting of the Members held September 14, 2022. A motion was made, seconded and carried to waive the reading of the minutes, and the minutes were thereupon declared to be approved and were ordered to be filed in the records of the Cooperative.

The annual report of CEO Keaton Hildreth was presented and ordered to be filed in the records of the Cooperative.

The Chairman stated that the next order of business was the election of three (3) directors for a term of three (3) years each. Attorney Colin C. Smith was introduced at this time.

Attorney Smith reported that the Nominating Committee consisting of District No. 1 - Mike Barrett, Gary Devereaux, Randy Pitstick; District No. 3 - Scott Hansch (Secretary), Adam Johnson, Steve Vosberg; District No. 5 - Kathy Juries, Keith Sexton (Chairman), Joel Wuebker; had nominated the following members for directors.
